We identify and fund scalable solutions that address Melbourne's big social and environmental challenges at a project and systems level. We support innovation and capacity building within the charitable sector. We support new ideas and test solutions. We can be first or early funders. We achieve more impact through collaboration, including with our donors, knowledge partners and co-funders. **We place a gender lens and a climate lens across our work.** We fund social enterprises across our outcomes and support the capacity of the social enterprise sector. We seek to align our work with the Sustainable Development Goals.

Our Logic: Lasting Change (positive impact) for people and place happens when we change systems. To change systems, our interventions are both focused and inter-connected and we take a long-term view. We apply all appropriate tools within the Philanthropy Toolbox to enhance impact. We measure our impact at an outcomes and systems level.

The Challenge has worked with local government and not for profit land owners to release land for affordable housing projects co-funded by the Foundation. This year, we will continue to work collaboratively with not for profit land owners and potentially a statutory authority to leverage well-located land suitable for affordable housing. <p>1.2 NEXT ECONOMY JOBS CHALLENGE</p> <p><i>An inclusive and sustainable economy and jobs</i></p>	<p>The COVID-19 Pandemic has exposed the vulnerability of social, economic and environmental systems in Greater Melbourne. As our city recovers, these complex interconnected problems need to be tackled together to withstand future shocks and ensure the economic security of the most disadvantaged members of our community. One of the greatest challenges and opportunities is to ensure economic inclusion and quality employment in a post-carbon future for young people, women, refugees and migrants, First Nations people and people with a disability. This Initiative will focus on catalysing new collaborations, and developing sustainable, inclusive, quality employment pathways in sectors such as clean technology, care economy (health, child & aged care), regenerative food/urban agriculture systems, eco-system services, community energy initiatives and waste/circular economy. <p>1.3 CLIMATE RESILIENT NEIGHBOURHOODS</p> <p><i>Healthy and climate resilient communities</i></p>	<p>Melbourne and its surrounding growth corridors face many intersecting challenges that are being exacerbated by climate change. These challenges are particularly affecting the Western and outer ring regions of Melbourne. This initiative will work to tackle the drivers of these challenges in order to demonstrate climate resilience at a neighbourhood scale. To do this, it will be a multi-impact initiative, connecting several priority areas including addressing the health implications of climate change, food security, environmental degradation, affordable housing, employment and access to transport and services. The initiative will support local efforts at the intersections of climate action, adaptation and justice, and be informed by leading practices such as 20-minute neighbourhoods, community power hubs and community resilience hubs.</p> <p>The 20-minute neighbourhood is all about 'living locally'—giving people the ability to meet most of their daily needs within a 20-minute walk from home, with safe cycling and local transport options.
